

BUSSINESSES CHARTER COMMITTED FOR CLEANLINESS

As a shop I am committed to:

- Maintain the immediate surroundings of the bussiness in clean conditions¹, that is to say :
 - Clean its immediate vicinity ;
 - Remove litter coming from the shop itself ;
 - Provide enough trash cans, visible, accessible, maintained and emptied regularly*;
 - Provide enough ashtrays for the number of people who are smoking in the immediate vicinity of the business**.

* Mandatory when selling food products that can be consumed immediately and right outside by customers. ** Mandatory for establishments in the hotel, restaurant and cafe business sector (horeca).

- ✓ Ensure the practibility² of passageways, sidewalks and road sides in the immediate vicinity of the business establishment.
- ✓ **Have** proof of good waste management (keep available for at least 5 years)³:
 - A contract with a waste collector registered (non-hazardous waste) and/of approved (hazardous waste)* by Brussels Environment, if my waste is collected;
 - An invoice or a certificate issued by a recypark or another authorized facility** for the collection and recycling of waste, if my waste is self-deposited there.

- ✓ Use my collector's bags and/or containers⁴.
- ✓ Sort⁵ my waste according to the following categories: PMC (plastic packaging, metal packaging, beverage cartons), paper and cardboard, glasses, residual waste.

Must also be sorted separately*: vegetable waste (green spaces and gardens), waste subject to a takeback obligation (batteries, medicines, grease and used frying oils, electrical and electronic waste, tires, solar panels and end-of-life vehicles), hazardous waste (ex. : flammable, corrosive, ecotoxic waste) or animal by-products (ex.: butchery waste).

*By the end of December 2022, sorting will also be mandatory for the following waste: bio waste (food and plant waste), plastic packaging films, metal, wood, frigolite, strapping ties, hard plastics, mattresses, rubble.

LABELLING STEPS :

- 1. You sign the charter and give it back to our service (either during our visit, or by contacting us to arrange an appointment, or by email);
- 2. You do what is necessary to comply with the 5 commitments of the charter within one month from the date of the signature of the document;
- 3. During a first control visit, you are able to prove compliance with each of the commitments;
- 4. Your business receives the "Business committed to cleanliness" label :
 - Communication tools are given to you so that you can display your commitment within your establishment (sticker + copy of the charter);
 - The name of your business and your picture appear on the municipal website;
 - Your business is periodically highlighted via the municipal communication channels;
- 5. At any time, you remain able to prove that you meet each of your commitments.
